Explanation of Responses:

1. Reporting person also has indirect beneficial ownership in the following: 195,900 held by Investar Burgeon Venture Capital, Inc.; and 23,850 held by Investar Avantgarde Holding, Inc., 384,140 held by Investar Capital, Inc. In addition, Reporting Person also has direct beneficial ownership of 181,000 shares.

2. Footnote for Table II - Summary of Derivative Securities: The Reporting Person owns directly three Stock Options (Right to Buy) with different vesting schedules described as follows: (i) 30,000 shares granted on June 26, 2000 at \$15.00 per share, vests 20% on 06/26/01 and 500 shares per month from 07/26/01 through 06/26/05; (ii) 6,000 shares granted on June 21, 2001 at \$20.58 per share, vests 500 shares per month from 07/21/05 through 06/21/06; and (iii) 6,000 shares granted on June 21, 2002 at \$21.59 per share, vests 500 shares per month from 07/21/06 through 06/21/07. All three Stock Options are immediately exercisable but not fully vested, and until fully vested, if exercised, would be subject to repurchase by the Company as to the unvested shares in the event of termination of the reporting person's services as a non-employee director of the Company.
