1. This option becomes exercisable as it vests as follows: 152,000 shares on 04/26/01, 12,667 shares per month beginning 05/26/01 until 04/26/05.

2. Summary of Derivative Securities: In addition, the Reporting Person owns directly three additional Stock Options (Right to Buy) with different vesting schedules described as follows: (i) 40,000 shares granted on January 2, 2001 at \$21.37 per share, vests 10,000 shares on 01/02/02, and 833 shares per month beginning 02/02/02 until 01/02/05; (ii) 40,000 shares granted on February 28, 2002 at \$30.69 per share, vests 10,000 shares on 02/03/03, 8,333 shares on 12/03/03, and 833 shares per month beginning 01/03/04 until 02/03/06; (iii) 70,000 shares granted on October 16, 2002 at \$13.87 per share, vests 70,000 shares on 10/16/2007. Options become exercisable as they vest.
