Explanation of Responses:

1. Of such 30,000 shares, vests 20% on 08/09/06 and 500 shares per month from 08/10/06 through 08/09/10. This option is not fully vested, and until fully vested, if exercised, would be subject to repurchase by the Company as to the unvested shares in the event of termination of the reporting person's services as a non-employee director of the Company.
2. Of such 14,000 shares, vests 20% on 08/09/06 and 233.33 shares per month from 08/10/06 through 08/09/10. This option is not fully vested, and until fully vested, if exercised, would be subject to repurchase by the Company as to the unvested shares in the event of termination of the reporting person's services as a non-employee director of the Company.
3. Of such 6,000 shares, vests 500 shares per month from 07/09/2010 through 06/09/2011; Stock Options are immediately exercisable but not fully vested, and until fully vested, if exercised, would be subject to repurchase by the Company as to the unvested shares in the event of termination of the reporting person's services as a non-employee director of the Company.
